Further to our disclosure dated 03 February 2023, the Securities and Exchange Commission (SEC) in its letter dated 08 February 2023 (received today), informed Bank of the Philippine Islands (the "Bank"), that the Commission *En Banc*, in its meeting on 07 February 2023, granted the request of the Bank to reduce the penalty to Php30,000,000.00 for omitting to secure SEC's confirmation of exemption from registration for its 2013-2019 Executive Stock Purchase Plan and Executive Stock Option Plan.
