INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Feeder Fund, aims to achieve long-term capital appreciation by investing in a Target Fund with a diversified portfolio of attractively-priced stocks with high dividend yields in the Asia Pacific region. It aims to outperform its benchmark which is the MSCI AC Asia Pacific ex-Japan High Dividend Net Return USD Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The Odyssey Asia Pacific High Dividend Equity Feeder Fund is suitable only for investors who:

- Are at least classified as <u>aggressive</u> based on their risk profile
- Have an investment horizon of at least five (5) years

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within 30 calendar days.



OUTLOOK AND STRATEGY

Market Review. Asian equities ended the month lower in May for a second consecutive month. Markets were tested amid the low visibility of China's economic recovery and mixed geopolitical developments stirred markets. MSCI Asia Pacific ex-Japan Net Index returned -2.4% for the month, with growth outperforming value. China and Hongkong detracted the most, while Taiwan, South Korea and India were the best performers, primarily driven by AI enthusiasm and momentum on foreign inflows.

Fund Performance. The fund returned -2.47% in May, underperforming the benchmark by 27 basis points as stock selection in China, mostly in financials and consumer discretionary, along with the underweight in India weighed down on performance. On the positive side, stock selection in IT and underweight in communication services helped the fund's performance.

Fund Strategy. Inflation has been falling across the world as issues of supply chain constraints, high shipping and energy costs, and commodity scarcity seem mostly resolved. Moreover, with a Fed on pause after a period of aggressive rate hikes, Asian central banks have room to cut or pause their own rate-hiking cycles. Furthermore, the earnings outlook for Asia Pacific is more encouraging than other regions in 2023, in large part because Asia Pacific experienced earnings downgrades throughout 2022. Looking ahead, we see less risk of repeated downward revisions and believe there may be upside in some sectors and countries due to China's reopening. The fund will continue to invest in equity securities in the Asia Pacific region (excluding Japan) that are expected to pay dividends.

- Single collective investment scheme whose investment objective is to achieve long-term capital appreciation by investing in attractively-priced stocks with high dividend yields in the Asia Pacific region; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS;
- b) Bank Deposits;
- Securities issued by or guaranteed by the Philippine government, or by the BSP; c)
- Tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF) d) and World Bank;
- Tradable securities issued by a government of a foreign country, any political subdivision of a foreign country or any supranational entity;
- f) Common shares, preferred shares, and convertible preferred share listed on the Philippine Stock Exchange or any organized stock exchange;
- Shares offered in an Initial Public Offering (IPO), provided that the company will be listed on the Philippine Stock Exchange or any organized stock g) exchange within the normal listing period (approximately 30 days from the start of the offer period);
- Exchange-listed securities and warrants of such securities; h)
- Marketable instruments that are traded in an organized exchange; i)
- i) Loanstraded in an organized market; and
- Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP.

INVESTMENT OBJECTIVE OF THE TARGET FUND

JP Morgan Asia Equity Dividend Fund aims to provide income and long-term capital growth by investing primarily in equity securities of companies in the Asia Pacific region (excluding Japan) that the Investment Manager expects to pay dividends. The benchmark of the Fund is MSCI AC Asia Pacific ex-Japan Net Index.
