INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Feeder Fund, aims to achieve long-term capital appreciation by investing in a Target Fund with a diversified portfolio of attractively-priced stocks with high dividend yields in the Asia Pacific region. It aims to outperform its benchmark which is the MSCI AC Asia Pacific ex-Japan High Dividend Net Return USD Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The Odyssey Asia Pacific High Dividend Equity Feeder Fund is suitable only for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within 30 calendar days.

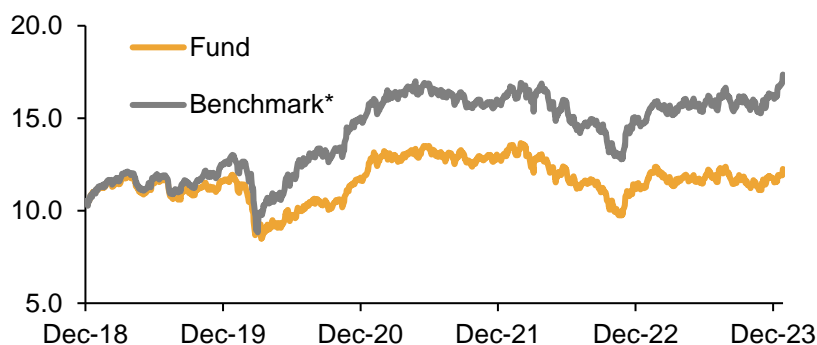

OUTLOOK AND STRATEGY

Market Review. Asian equities ended the month up in December. During the month, a surprise from the Fed led to a scenario where rate cuts are expected to be sooner. The US 10-year treasury yield ended lower and the US dollar depreciated. Most Asian markets ended the month in the green. India, Australia and Korea appreciated the most, while Thailand and Malaysia appreciated the least. India was up on favorable state election results towards Prime Minister Modi. Australia gained as the materials sector was boosted by higher iron ore prices. Korea outperformed as economic indicators such as exports and PMI beat market expectations. Thailand's trade balance fell further during the month, increasing the deficit. Investors remained cautioned in Malaysia as inflation rose and trade levels decreased. China was the only negative market during the month. China corrected during the month as consumer confidence levels highlighted the low retail sales volumes over the past few months.

Fund Performance. The fund returned 2.89% in December, underperforming the benchmark by 383 basis points. Stock selection in financials detracted from performance as rate sensitive names were affected by markets pricing in a rate cut environment in the future.

Fund Strategy. Headline inflation has been falling across the world as the major issues of supply chain constraints, high shipping and energy costs, and commodity scarcity seem mostly resolved. With the Fed looking to be much closer to the end of its hiking cycle and now much more data dependent on how much further it needs to raise short-term rates this year, Asian central banks may well have room pause or start their own rate-cutting cycles. While China's policy pendulum has swung more pro-growth and business, the sugar rush of a large fiscal stimulus is not expected as the authorities are more focused on sustainable growth and removing tail risks from the real estate sector. Chinese consumption should recover, albeit gradually over the coming year, in turn supporting earnings. Asian corporates look well positioned for the next decade's big trends: investment in materials and manufactured goods to support carbon transition and high-powered computing spurred on by AI adoption. The fund will continue to invest in equity securities in the Asia Pacific region (excluding Japan) that are expected to pay dividends.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- Single collective investment scheme whose investment objective is to achieve long-term capital appreciation by investing in attractively-priced stocks with high dividend yields in the Asia Pacific region; provided further that such CIS is approved or registered and supervised by a regulatory authority that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s; provided further that the investment in the said collective investment scheme should at least be ninety percent (90%) of the total assets of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS;
- Bank Deposits;
- Securities issued by or guaranteed by the Philippine government, or by the BSP;
- Tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF) and World Bank;
- Tradable securities issued by a government of a foreign country, any political subdivision of a foreign country or any supranational entity;
- Common shares, preferred shares, and convertible preferred share listed on the Philippine Stock Exchange or any organized stock exchange;
- Shares offered in an Initial Public Offering (IPO), provided that the company will be listed on the Philippine Stock Exchange or any organized stock exchange within the normal listing period (approximately 30 days from the start of the offer period);
- Exchange-listed securities and warrants of such securities;
- Marketable instruments that are traded in an organized exchange;
- Loans traded in an organized market; and
- Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP.

INVESTMENT OBJECTIVE OF THE TARGET FUND

JP Morgan Asia Equity Dividend Fund aims to provide income and long-term capital growth by investing primarily in equity securities of companies in the Asia Pacific region (excluding Japan) that the Investment Manager expects to pay dividends. The benchmark of the Fund is MSCI AC Asia Pacific ex-Japan Net Index.
