INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance in its process, investment criteria the of incorporation including sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and projects, and other adaptation positive environmental and social impact initiatives.

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Sustainable Global Balanced Fund-of-Funds is for investors who:

- Are at least classified as aggressive based on their risk profile.
- Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days



OUTLOOK AND STRATEGY

Market Review. Global equities pulled back in April with the MSCI All Country World Index returning -3.2% after higher-than-expected inflation dampened hopes of interest rate cuts in the near term. In the US, the S&P 500 returned -4.1% as the expected timing and magnitude of rate cute adjusted and hotter CPI print led yields to rise. Outside the US, Europe posted improved growth evidenced by the flash composite PMI rising to 51.4 which led European equities to fare better than their US counterparts. At the same time, year-over-year inflation remained flat at 2.4% which provided confidence in the prospects for rate cuts from the European Central Bank (ECB). In Japan, equity markets pulled back amid profit-taking after a strong first quarter, with the Nikkei 225 Index returning -4.9% for the month. Elsewhere, Chinese markets saw an impressive rebound driven by improving sentiment towards the region supported by a better-than-expected Q1 GDP print at 5.3% year-on-year.

Within the fixed income space, global markets declined in April with the Bloomberg Barclays Global Aggregate Bond Index returning -2.5% due to shifting rate expectations. Inflation remained the spotlight for the month, as the Consumer Price Index (CPI) in the US for March ticked up 0.4% month-on-month, taking annual inflation to 3.5%. European Central Bank (ECB) president Christine Lagarde continued to signal June as an appropriate time to ease monetary policy conditions. The US Federal Reserve, ECB, and Bank of England all left their key interest rates unchanged at 5.50%, 4.00% and 5.25%, respectively. Within government bonds, US led the sell-off, with the 10-year Treasury yield rising 48 basis points to 4.7% as the market embraced a higher-for-longer narrative regarding interest rates. Eurozone rates markets also sold off in April but yields rose less than US Treasuries as inflation cam in-line with market expectations. Within the credit space, high-yield and emerging market fixed income securities outperformed comparable government and investment-grade bonds amid the continued resilience of economies. Credit spreads modestly tightened with US investment grade, US high-yield and emerging-market spreads narrowing by 2.8, 3.0 and 7.2 basis points, respectively.

Fund Performance. The fund returned -2.12%, outperforming the benchmark by 82 basis points. Security selection within global equities detracted from performance.

Fund Strategy. We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.
