INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance in its process, investment criteria the of incorporation including sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and projects, and other adaptation positive environmental and social impact initiatives.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Sustainable Global Balanced Fund-of-Funds is for investors who:

- · Are at least classified as aggressive based on their risk profile.
- · Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.



OUTLOOK AND STRATEGY

Market Review. Global equities saw positive returns in June with the MSCI All Country World Index returning 2.26% with mixed performances across all regions. The US continued their positive streak with the S&P 500 returning 3.59% led by the technology sector. The US Federal Reserve also kept rates unchanged at 5.50%, indicating that a rate cut is possible by year-end. Additionally, jobs report for June showed 218,000 new jobs added, above estimates of 190,000, and the unemployment rate rose to 4.0% in May, the first time in more than two years. European equity markets saw a decline with the MSCI Europe Index falling 0.96% as political developments undermined confidence due to the potential changes in the business and economic environment. The European Central Bank began its easing cycle during the month, cutting interest rates from 4.00% to 3.75%, but noted that further rate cuts remain uncertain. The Asia Pacific region showed strong performance, with Taiwan and Korea particularly benefiting from the ongoing recovery in Asian exports and the anticipated increase in hardware demand driven by artificial intelligence advancements. However, China's performance was hindered by the absence of new stimulus measures and cautious consumer sentiment.

Within the fixed income space, global markets were flat in June with the Bloomberg Barclays Aggregate Bond Index returning 0.14%. In addition to keeping policy rates steady, the FOMC indicated that a rate cut may be delayed until economic data provides a strong case for a cut. Despite the Fed's updated forecasts for fewer rate cuts this year, weaker economic and inflation data in the US have driven US Treasury yields lower with the 10-year US Treasury yield falling to 4.40% from 4.50%, while the 2-year yield dropped to 4.75% from 4.87%. Meanwhile, the ECB is moving back to a data-dependent approach following its 25 basis point rate cut as ECB President Lagarde noted that recent inflation data could have been better. Additionally, the evolving political landscape, particularly in France, is raising worries about high fiscal deficits and growing government debt. Emerging market debt posted mixed returns in June with hard currency outperforming local currency fixed income amid continued dollar strength. Corporate credit spreads remained stable for the month, with US investment-grade and high-yield spreads widening slightly by 9.4 and 4.9 basis points, ending the month at 93.2 and 310.6 basis points, respectively.

Fund Performance. The fund returned 1.13%, outperforming the benchmark by 1 basis point. Security selection within global equities helped performance.

Fund Strategy. We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.
