

### INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance in its process, investment criteria the of incorporation including sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and projects, and other adaptation positive environmental and social impact initiatives.

#### **CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The BPI Sustainable Global Balanced Fund-of-Funds is for investors who:
- Are at least classified as aggressive based on their risk profile.
- Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.



### OUTLOOK AND STRATEGY

**Market Review.** Global equities rebounded in May after April's pullback, with the MSCI All Country World Index returning 4.1% for the month as investor sentiment improved amid easing inflation concerns. In the US, the S&P 500 returned 5.0% driven by strong corporate earnings despite rate cuts being pushed back to later this year. The Flash PMI indicated further expansion in business activity, with the manufacturing and services PMIs accelerating to 51.3 and 54.8 in May from 50.0 and 51.3 last month. Eurozone equities advanced driven by increase in business activity and an anticipated policy rate cut in June by the European Central Bank. In Japan, the TOPIX returned 1.1%, lagging the broader global index, as the continued weakness of the Yen dampened market sentiment. Emerging market equities were flat for the month, with the MSCI Emerging Market Index returning 0.6%. Returns were supported by China's improving economic data and stimulus and optimism on the Fed's rate cuts but was offset by profit-taking and risk-off sentiment towards the end of the month.

Within the fixed income space, global fixed income markets saw positive returns in May with the Bloomberg Barclays Global Aggregate Bond index returning 1.3%. In the US, Federal Reserve chairman Jerome Powell left their benchmark policy rate unchanged in the FOMC meeting in May, noting that confidence in the inflation path to 2% will likely take longer than expected. However, recent inflation data showed a slight decrease in both headline and core categories, with year-over-year (YoY) rates in May down to 3.3% and 3.4%, respectively. This helped US Treasuries over the month, with 2-year and 10-year yields falling by 16 and 18 basis points, respectively. In the eurozone, the European Central Bank is still expected to lower policy rates in June. However, headline and core inflation rose to 2.6% and 2.9% YoY in May, respectively, indicating that additional cuts thereafter are still uncertain. In other regions, Emerging Market debt posted strong returns of 1.7%, as several EM central banks have already started their easing cycles. Within credit fixed income, strong corporate fundamentals provided support as spreads narrowed, with investment grade credit performing well over the month.

Fund Performance. The fund returned 2.80%, outperforming the benchmark by 24 basis points. Security selection within global equities helped performance.

**Fund Strategy.** We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

- (b) Primarily in more than one collective investment scheme managed using a sustainable investment strategy aligned with sustainability metrics or frameworks such as the European Union Sustainable Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals(SDG), and other globally recognized fund rating agencies or companies, that are approved or registered and supervised by regulatory authorities that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s the investment objectives and policies of which are generally consistent with those of the Fund; provided further that such combined investment in collective investment schemes should not fall below ninety percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.

- (d) Money market instruments;
