**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund, operating as a Fund-of-Funds, seeks to achieve long-term capital growth by investing in a diversified portfolio of global equity and fixed income collective investment schemes which integrate environmental, social, and governance in its process, investment criteria the of incorporation including sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and projects, and other adaptation positive environmental and social impact initiatives.

**CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Sustainable Global Balanced Fund-of-Funds is for investors who:

- Are at least classified as aggressive based on their risk profile.
- Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

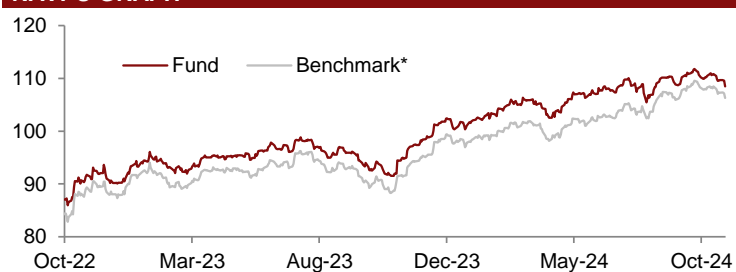

## OUTLOOK AND STRATEGY

**Market Review.** Global equities declined in October, with the MSCI All Country World Index posting a -2.2% return. In the US, the S&P 500 posted a modest decline of 0.9%, influenced by the uncertainty surrounding the upcoming national elections and mixed expectations on the path of policy rates. Inflation saw a slight improvement as the Consumer Price Index (CPI) eased to 2.4% in September from 2.5% in August, fueling hopes for a 25-basis point rate cut in November. US GDP grew at an annualized rate of 2.8% year-on-year in Q3, slightly down from 3.0% year-on-year growth in the 2nd quarter. Labor markets continued to be robust as nonfarm payrolls saw a strong increase with 254,000 jobs added in September compared to 154,000 in August while unemployment declined from 4.2% to 4.1% month-on-month. In Europe, the MSCI Europe Index decreased by 3.2%. The European Central Bank (ECB) cut interest rates by 25 basis points in October, its third quarter-point cut for the year. 3Q GDP slightly improved by 0.4% quarter-on-quarter, however, inflation rose to 2.0% in October from 1.7% in September. This supported the view of ECB President Christine Lagarde that rate cuts should continue to be gradual moving forward. In Japan, equity markets were positive and the TOPIX rose by 1.9% as the country's expansionary policy plans and weaker yen boosted returns. Emerging markets faced headwinds from a stronger US dollar and weaker corporate earnings for the third quarter and the MSCI Emerging Market Index fell by 4.3% for the month.

Within the fixed income space, global fixed income markets declined in October, with the Bloomberg Global Aggregate Bond Index falling by 3.4%. Continued economic strength in the US and uncertainties surrounding the upcoming US national election contributed to a slower expected pace of the Federal Reserve rate cuts. Although the US Presidential election race remained close between the nominees, presidential candidate Donald Trump maintained a lead in the polls towards the end of the month. As a result, US Treasuries experienced a sell-off as a potential Republican victory raises inflationary concerns around the possible reforms in fiscal spending. Yields across the US Treasury yield curve increased, with the 2-year, 10-year, and 30-year notes increasing by 53, 50, and 36 basis points to end October at 4.2%, 4.3%, and 4.5%, respectively. Credit markets outperformed the broader fixed income market, with global investment grade, high yield, and emerging market debt falling 2.7%, 0.6%, and 1.4%, respectively, as spreads tightened across all sectors.

**Fund Performance.** The fund returned -2.55%, outperforming the benchmark by 26 basis points. Security selection within the fund helped performance.

**Fund Strategy.** We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.
