INVESTMENT OBJECTIVE AND STRATEGY

The Fund, operating as a Fund-of-Funds, seeks to achieve capital appreciation and income by investing in a diversified portfolio of global fixed income collective investment schemes which integrate environmental, social, and governance criteria in its investment process, including the incorporation of sustainability goals and facilitation of flow of funds towards green economic activities, climate change mitigation and adaptation projects, and other positive environmental and social impact initiatives. It aims to outperform its benchmark which is the Bloomberg Barclays Global Aggregate Bond Index (Unhedged).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Sustainable Global Bond Fund-of-Funds is for investors who:

- · Are at least classified as moderately aggressive based on their risk profile.
- · Have an investment horizon of at least five (5) years.

Participation in the Fund shall be open to Participants with legal capacity to contract and who are not considered US persons under the US securities and tax laws, subject to the other conditions, rules or provisions stated in the Plan Rules and those established by the Trustee. No beneficial owner shall hold more than 10% of the Fund. Any investor who owns more than 10% shall be asked to redeem the amount (or its equivalent number of units) in excess of 10% within thirty (30) calendar days.

Market/Price Risk:

Investors are exposed to adverse changes in the prices of foreign currency denominated fixed income instruments of the target funds due to a rise in interest rates as a result of adverse market conditions, unfavorable developments in the political and economic conditions of countries where the underlying securities of the target funds are issued or traded, or other issuer-specific factors.

Liquidity Risk:

Investors are exposed to the risk of loss due to the inability of the target funds to convert security holdings to cash immediately or in instances where conversion to cash is possible but at a highly disadvantageous price due to limited participants in the market, low trading volumes, market disruptions, among others.

Interest Rate Risk:

Investors are exposed to adverse changes in the prices of fixed income securities of the target funds due to a rise in interest rates, which generally causes fixed income security prices to decline. 

OUTLOOK AND STRATEGY

Market Review. Global fixed income markets were flat in June with the Bloomberg Barclays Aggregate Bond Index returning 0.14%. The FOMC held policy rates at 5.50%, indicating that a rate cut may be delayed until economic data provides a strong case for a cut. Despite the Fed's updated forecasts for fewer rate cuts this year, weaker economic and inflation data in the US have driven US Treasury yields lower with the 10-year US Treasury yield falling to 4.40% from 4.50%, while the 2-year yield dropped to 4.75% from 4.87%. The European Central Bank (ECB) led the developed market central banks in implementing easing monetary policy by cutting its rates by 25 basis points to 3.75%. The ECB is moving back to a data-dependent approach as ECB President Lagarde noted that recent inflation data could have been better. Additionally, the evolving political landscape, particularly in France, is raising worries about high fiscal deficits and growing government debt. Emerging market debt posted mixed returns in June with hard currency outperforming local currency fixed income amid continued dollar strength. Corporate credit spreads remained stable for the month, with US investment-grade and high-yield spreads widening slightly by 9.4 and 4.9 basis points, ending the month at 93.2 and 310.6 basis points, respectively.

Fund Performance. The fund returned 0.67%, outperforming the benchmark by 53 basis points. Sector allocation within the fund helped performance.

Fund Strategy. We expect major structural trends in sustainability, such as increasing market share of electric vehicles and record installation of wind turbines and solar panels, to continue. The ongoing Russia-Ukraine war, has resulted in the world, particularly Europe, determined to reduce their reliance on traditional sources of energy such as oil in gas, requiring large investments in renewable energy in the coming years. In addition, we continue to see support for green technologies through government policies across the globe. We believe that strong ESG companies are likely to generate positive financial performance over time as investing in sustainability can deliver higher growth and returns through innovation, higher operational efficiency and better risk management.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily in more than one collective investment scheme managed using a sustainable investment strategy aligned with sustainability metrics or frameworks such as the European Union Sustainable Finance Disclosure Regulation (SFDR), United Nations Sustainable Development Goals (SDG), and other globally recognized fund rating agencies or companies, that are approved or registered and supervised by regulatory authorities that is a member of the International Organization of Securities Commissions (IOSCO) and managed by reputable fund manager/s the investment objectives and policies of which are generally consistent with those of the Fund; provided further that such combined investment in collective investment schemes should not fall below ninety percent (90%) of the net asset value of the Fund. The Target Fund must be recognized as a collective investment scheme in its home jurisdiction by a regulatory authority or any regulatory authority acceptable to the BSP to supervise this CIS.
- b) Deposit products;
- c) Money market instruments;
- d) Short-term tradable fixed-income instruments issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund; and, any such other instruments as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Section 414-Q of the Manual of Regulations for Non-Bank Financial Institutions;
- e) Such other investments suitable to the nature, classification, and strategy of the Fund, as allowed by prevailing regulations.
- f) The principal investments of the Fund will be denominated in, but not limited to, the following major currencies: U.S. Dollar, Euro, British Pound, Canadian Dollar, Australian Dollar, Swiss Franc, Danish Kroner, and Japanese Yen.
