The Fund is for US Dollar investors who want to achieve capital appreciation and income growth over a period of time. To achieve this, the Fund will be invested in a diversified portfolio of US dollar-denominated fixed income instruments issued by the Philippine government, corporations, & financial institutions. The Fund aims to outperform its benchmark, the JP Morgan Chase Asia Total Return Philippines Index.



#### **RELATED PARTY TRANSACTIONS**

#### OUTLOOK AND STRATEGY

**Market Review.** In January 2025, international fixed income investments performed well, with the Bloomberg Aggregate Bond Index (Global) up 0.93% and JP Morgan Asia Credit Index (JACI) up 0.22% year-to-date. This was due to lower yields from softer-than-expected US inflation and comments from the Federal Reserve (Fed) official about possible rate cuts. However, mixed messages from other Fed officials, including Fed Chair Jerome Powell, who saw no rush for rate cuts, tempered gains. The US economy grew slower than expected in the last quarter of 2024, but consumer spending remained strong. Inflation rose slightly, driven by higher energy costs, but core inflation showed signs of cooling. The Fed kept its interest rates steady, with the Chair emphasizing the need to monitor economic data before making further changes.

Fund Performance. The Fund returned -0.10% for the month, underperforming its benchmark by 30 basis points.

**Fund Strategy**. The Fund looks to maintain its duration position as interest rates are expected to decline in the medium term. Global events remain likely to add volatility. Investors in a bond fund must be prepared to withstand volatility as higher investment value is typically achieved over the medium to long term.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Bank deposits and such other investments allowed under regulations issued by the BSP;
- b) Securities issued by or guaranteed by the Philippine government, or by the BSP;
- c) Tradable securities issued or guaranteed by multilateral institutions such as the Asian Development Bank (ADB), International Monetary Fund (IMF) and World Bank;
- d) Tradable securities issued by the government of a foreign country, any political subdivision of a foreign country or any supranational entity;
- e) Exchange-listed securities;
- f) Marketable instruments that are traded in an organized exchange;
- g) Loans traded in an organized market;
- Such other tradable investments outlets/categories as may be approved by the relevant authority and allowed by the BSP; and
- i) The Trustee may invest in allowable investments denominated in any acceptable foreign currency.
