Please be informed that at the regular Board meeting of Bank of the Philippine Islands (BPI) held today, 16 November 2022, the Board approved the following:

1. Calling of a Special Stockholders' Meeting to be held on 17 January 2023, 9:00 AM for purposes of securing the required shareholders' approval in connection with the (i) proposed merger between BPI and Robinsons Bank Corporation ("RBC") with BPI as the surviving bank, and (ii) amendments to Article SEVENTH of the Articles of Incorporation of the Bank. Stockholders of record date as of 01 December 2022 will be entitled to notice and vote at said meeting. Submission of proxy forms to the Office of the Corporate Secretary should not be later than 06 January 2023. Further, pursuant to Articles XII of the Amended By-Laws of BPI, the Stock Transfer Book of BPI will be closed 30 days immediately preceding the stockholders' meeting or starting 18 December 2022 to 16 January 2023.

2. Declaration of cash dividend of One Peso and Six Centavos (PHP1.06) per share, for the second semester of the year 2022, on the total outstanding common shares of the capital stock of BPI. Record date is 01 December 2022 and payment date is on 23 December 2022.
